As per the Regulations notified by the Council vide F. No. 04/007/2003-05/, F.No. 37-3/Legal/ 2011 dated 06.02.2010 and other notification and norms standards procedures and conditions prescribed by the Council from time to time, the compliance report received from the institution for consider, Surprise Inspection Report, extension or otherwise for 2010-2011 was examined by the Council through a duly constituted Appellate Committee and its was observed that the institution had failed to completely comply with AICTE Norms.

Whereas, the AICTE conveyed the extension of approval to Mount Zion College of Engineering for Women Kozhuvalloor (P.O.) Chengannur, Alapuzha – Eistrict, Kerala – 689521 for the academic year 2010-11 subject to the condition that Institute should adhere to regulations, guidelines and directions issued by AICTE from time to time and follow the undertaking/ affidavit given/by the institution along with the application submitted by the Institute for the portal and hard copy to R.G. Further the approval is subject to the institutions strictly complying with all the provisions made under the Anti ragging regulation notified by council vide F.No.37/Legal/AICTE/2009 dated 01.07.2009 failing which, it will be liable to any action defined under clause 9(4) of this regulation.

In the event of non-compliance by the Mount Zion College of Engineering for Women Kozhuvalloor (P.O.) Chengannur, Alapuzha – District, Kerala – 689521 with regard to guidelines, norms and conditions prescribed from time to time the council shall be free to take measures for withdrawal of its approval or recognition, without consideration of any related issue and that all liabilities arising out of such withdrawal would solely be that of that Mount Zion College of Engineering for Women Kozhuvalloor (P.O.) Chengannur, Alapuzha, – District, Kerala – 689521

Therefore, in view of the facts and circumstances mentioned herein above, you are hereby directed to Show Cause as to why:

- 1. It should not be considered that AICTE was misled by the institute by giving manipulated/ false information.
- 2. It should not be considered as violation of the terms and conditions contained in the letter of approval.
- 3. Appropriate actions, including withdrawal of the approval be not initiated against the institution for non-observance of the terms and condition of approval as also for misleading the AICTE by submitting false information.

The reply of the institution in this respect must reach the Council within 10 days from the date of issue of this letter failing which, it will be presumed that the Institute have nothing to state in this regard and the Council shall take suitable decision in the absence of response.
