Sir,

This has a reference to the letter, F. No. 06/06/KER/ENGG(W)/2009-10/007 dated 03.08.2011, with a subsequent corrigendum dated 25.08.2011 issued by AICTE to Mount Zion College of Engineering for Women, Kozhuvallur, Chengannur, Alappuzha-Distt., Kerala-689521, pertaining to Fifty Percent (50%) Intake reduction in all courses for the A.Y. 2011-12.

The Council reviewed the case for the academic year 2012-13 and conducted Expert Visit Committee (EVC) on the institute on 5th June, 2012. The EVC observed following deficiencies:

- Copy of advertisement in at least one/ national Daily, for recruitment of principal/Director and faculty members - "Not presented".
- General insurance provided for assets against fire, burglary and other calamities - "Not presented".


The EVC report was placed before the Standing Complaint Committee (S.C.C) on 25.07.2012 and an opportunity was also given to the College to present their case. The SCC has given following recommendations:

- It is recommended that the existing (50% reduction in intake) to continue as no proof for regular Principal appointment is provided.
- Existing status (50% reduction in intake to continue)"

Therefore, it has been decided that the penalty of Fifty Percent (50%) intake reduction in all courses imposed on Mount Zion College of Engineering for Women, Kozhuvallur, Kerala for the A.Y. 2011-12, shall be continued for the year 2012-13 as given below:
